### A. Format

Article files should be provided in Microsoft Word format.

While you are welcome to submit a PDF of the document alongside the Word file, PDFs alone are not acceptable. LaTeX files can also be used but only if an accompanying PDF document is provided. Acceptable figure file types are listed further below.

### B. Article Length / Word Count

Articles should be up to a maximum of 5000 words in length. This includes all text, for example, the structured abstract, references, all text in tables, and figures and appendices

### C. Article Title

A concisely worded title should be provided

### D. Biographies and acknowledgements

If you want to include these items, save them in a separate Microsoft Word document and upload the file with your submission. Where they are included, a brief professional biography of not more than 100 words should be supplied for each named author

## E. Author details

The names of all contributing authors should be added to the ScholarOne submission; please list them in the order in which you’d like them to be published. Each contributing author will need their own ScholarOne author account, from which we will extract the following details:

**Author email address** (institutional preferred).

- **Author name.** We will reproduce it exactly, so any middle names and/or initials they want featured must be included.

**Author affiliation.** This should be where they were based when the research for the paper was conducted.

In multi-authored papers, it’s important that ALL authors that have made a significant contribution to the paper are listed.

Those who have provided support but have not contributed to the research should be featured in an acknowledgements section. You should never include people who have not contributed to the paper or who don’t want to be associated with the research.

## F. Research funding

Your article must reference all sources of external research funding in the acknowledgements section. You should describe the role of the funder or financial sponsor in the entire research process, from study design to submission

## G. Structured abstract

All submissions must include a structured abstract, following the format outlined below. These four sub-headings and their accompanying explanations must always be included:

**Purpose**

**Design/methodology/approach**

**Findings**

**Originality**

The following three sub-headings are optional and can be included, if applicable:

**Research limitations/implications**

**Practical implications**

**Social implications**

The maximum length of your abstract should be 250 words in total, including keywords and article classification (see the sections below).

## H. Keywords

Your submission should include up to 12 appropriate and short keywords that capture the principal topics of the paper. Please note, while we will always try to use the keywords you’ve suggested, the in-house editorial team may replace some of them with matching terms to ensure consistency across publications and improve your article’s visibility

## I. Headings

Headings must be concise, with a clear indication of the required hierarchy. The preferred format is for first level headings to be in bold, and subsequent sub-headings to be in medium italics

## J. Notes/endnotes

Notes or endnotes should only be used if absolutely necessary. They should be identified in the text by consecutive numbers enclosed in square brackets. These numbers should then be listed, and explained, at the end of the article.

## K. Article classification

During the submission process, you will be asked to select a type for your paper; the options are listed below. If you don't see an exact match, please choose the best fit:

Research Article

Review Article

You will also be asked to select a category for your paper. The options for this are listed below. If you don't see an exact match, please choose the best fit:

Research paper. Reports on any type of research undertaken by the author(s), including:

- The construction or testing of a model or framework

Action research

Testing of data, market research or surveys

Empirical, scientific or clinical research

Papers with a practical focus

Viewpoint. Covers any paper where content is dependent on the author's opinion and interpretation. This includes journalistic and magazine-style pieces.

Technical paper. Describes and evaluates technical products, processes or services. Conceptual paper. Focuses on developing hypotheses and is usually discursive. Covers philosophical discussions and comparative studies of other authors' work and thinking. Case study. Describes actual interventions or experiences within organizations. It can be subjective and doesn't generally report on research. Also covers a description of a legal case or a hypothetical case study used as a teaching exercise.

Literature review. This category should only be used if the main purpose of the paper is to annotate and/or critique the literature in a particular field. It could be a selective bibliography providing advice on information sources, or the paper may aim to cover the main contributors to the development of a topic and explore their different views.

General review. Provides an overview or historical examination of some concept, technique or phenomenon. Papers are likely to be more descriptive or instructional („how to" papers) than discursive.

## L. Figures

All figures (charts, diagrams, line drawings, webpages/screenshots, and photographic images) should be submitted electronically. Both colour and black and white files are accepted.

There are a few other important points to note:

All figures should be supplied at the highest resolution/quality possible with numbers and text clearly legible.

Acceptable formats are .ai, .eps, .jpeg, .bmp, and .tif.

- Electronic figures created in other applications should be supplied in their original formats and should also be either copied and pasted into a blank MS Word document, or submitted as a PDF file.

All figures should be numbered consecutively with Arabic numerals and have clear captions.

All photographs should be numbered as Plate 1, 2, 3, etc. and have clear captions

## M. Tables

Tables should be typed and submitted in a separate file to the main body of the article. The position of each table should be clearly labelled in the main body of the article with corresponding labels clearly shown in the table file. Tables should be numbered consecutively in Roman numerals (e.g. I, II, etc.).

Give each table a brief title. Ensure that any superscripts or asterisks are shown next to the relevant items and have explanations displayed as footnotes to the table, figure or plate.

## N. For books

Surname, initials (year), title of book, publisher, place of publication.

## P. References

All references in your manuscript must be formatted using one of the recognised Harvard styles. You are welcome to use the Harvard style Emerald has adopted – we’ve provided a detailed guide below. Want to use a different Harvard style? That’s fine, our typesetters will make any necessary changes to your manuscript if it is accepted. Please ensure you check all your citations for completeness, accuracy and consistency.

**(B) PUBLICATION** All the papers / Abstracts will be published in conference volume and some selected papers will be published in Journal of IEA/ Reputed Journal and/or Edited Book. The paper writer/s shall be fully responsible for the research integrity, originality & publication ethics of the research paper. Each author will have to submit the declaration of copy right & plagiarism on the prescribed format to IEA.

**(C) BEST PAPER PRESENTATION AWARDS FOR YOUNG ECONOMISTS** On the basis of content, quality, language and presentation, four Awards will be given for Best Paper Presentation in each thematic area to Research Scholars/Students and the four Awards will be given for Best Paper Presentation in each thematic area to Young Economists in the category of teachers below 40 years of age, For the presentation of the Award/Certificate, the Best Paper presenter/s for each theme will be adjudicated by the Jury containing Chairpersons, Co-chairpersons and Rapporteurs. Papers from the Chairpersons/Co-chairpersons/Rapporteurs will not be considered for the Medal. Papers should reach to the Secretary, IEA on or before the notified date. For the presentation of the Gold Medal/ Certificate, the Best Paper author/s for each theme will be adjudicated by the Jury containing Chairpersons, Co-chairpersons and Rapporteurs. The Jury of each Technical Session will select one best paper from each of the four themes. This selection of the best paper would be made on the basis of the quality of the Paper and the presentation of the same during the Conference. The Secretary will be coordinating the entire process. The decision of the best research paper awardee is jointly made by the ex-officio President and Secretary of the IEA after scrutinizing the Jury reports of the various technical sessions.

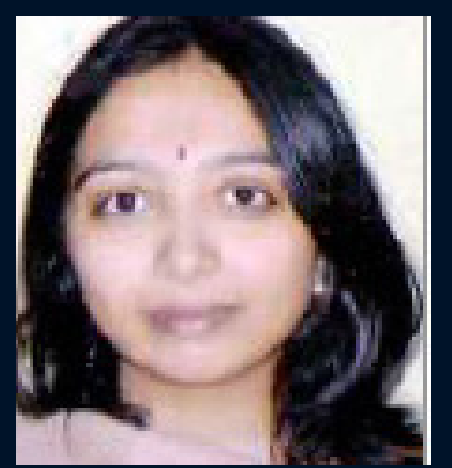
