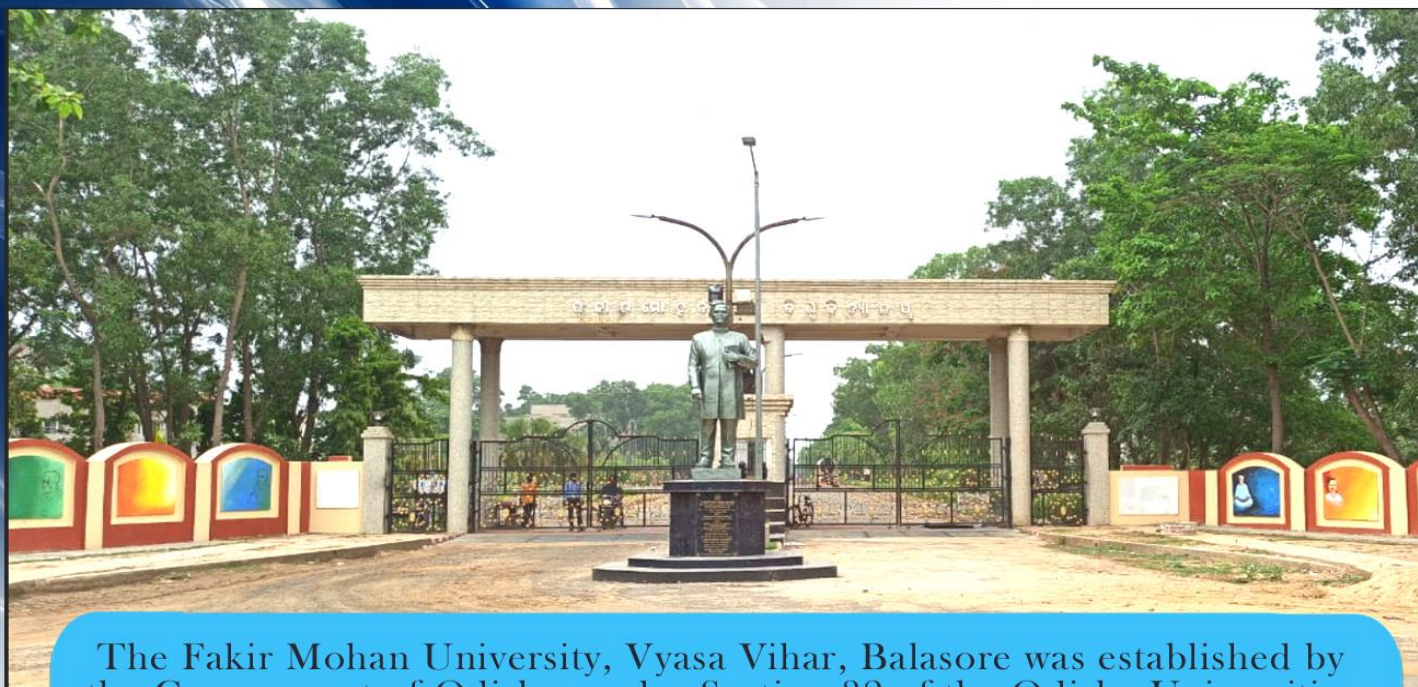

Dr. Shri Prakash obtained Master's Degree in Economics from University of Allahabad and obtained Ph.D from University College of Wales, UK. He has a very long teaching and research experience. He has published 12 books and 270 research papers, including 61 papers published in foreign journals.

Dr. Shri Prakash has served at various institutions of national importance. He is among three scholars who alone have analysed Private Demand for Education in the world. His book on Cost of Education is among a couple books available on this topic. His book on Expenditure on Education-Theory, Growth and Application is the only book on the subject. He has developed both Theory and Models of Educational Expenditure with application to Indian data. He is among about a dozen econometricians of education recognized internationally. His study on **Literacy and Development** is a significant contribution to the subject. He successfully guided 28 Ph.D and 12 M.Phil. Scholars. He has been **Visiting Professor at various foreign universities**

He has contributed many papers and chaired sessions at several International Conferences. He has been consultant to UNICEF, UNESCO and World Bank. His last three books are (i) Theory of Consumer Behaviour, and (ii) Dynamics of Underdevelopment of Uttar Pradesh (iii) Public Expenditure and Growth- A comparative Study of India and Tanzania.

Dr. Shri Prakash worked as a Secretary, Input-Output Research Association, India. Member of EC, IIOA, Vienna. Vice-President, North-East India Geographical Society. Member Governing Board, North East India Council of Historical Research. Member, Task force Planning Commission Regional Agricultural Development; Expenditure on Education. Special Invitee to Financial Commission for the Allocation of Funds to Education. Director, Long term Land use project (Planning Commission).

He is an awardee of **Kautilya Award of UPUA** and **J.K. Mehta Award** for research and teaching. This august gathering of academicians is privileged to honour you Sir with its coveted award named after Late Shri Atal Bihari Bajpai former Prime Minister of India.

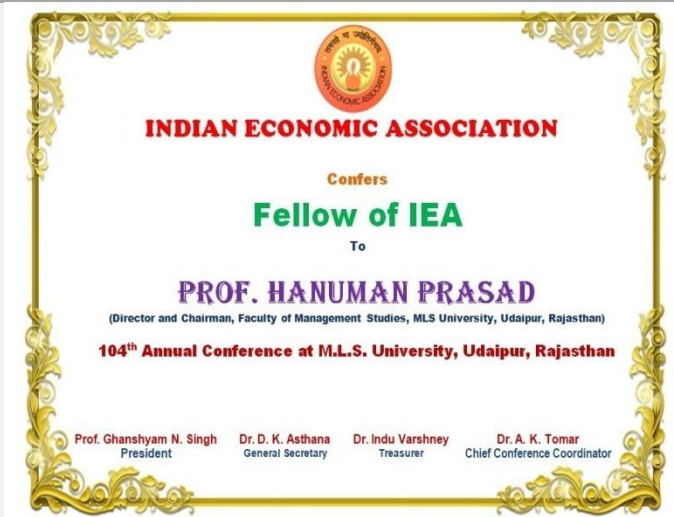

- If your study has been funded or supported by any institution, agency, etc, please indicate the same under "Acknowledgement"
- The full article must be submitted as a MS Word file in .DOC or .DOCX format or in PDF format.
- Before submitting your paper, please ensure that the English used is clear, concise and coherent.
- Upload the full paper through the website. Once the full paper is accepted, author(s) will be requested to submit the copyright transfer form.
- Any paper which does not follow the guidelines may not be considered for publication in the conference proceedings.

## Places to visit



### Jagannath Temple, Puri

5 hr 17 min (253.5 km) via NH16 From Balasore

The traditional story concerning the origins of the Lord Jagannath temple is that here the original image of Jagannath (a deity form of Vishnu) at the end of Dvapara yuga manifested near a banyan tree, near seashore in the form of an Indranila mani or the Blue Jewel. It was so dazzling that it could grant instant moksha, so the God Dharma or Yama wanted to hide it in the earth and was successful. In Kali Yuga King Indradyumna of Malwa wanted to find that mysterious image and to do so he performed harsh penance to obtain his goal. Vishnu then instructed him to go to the Puri seashore and find a floating log to make an image from its trunk.

The King found the log of wood. He did a yajna from which God Yajna Nrisimha appeared and instructed that Narayana should be made as fourfold expansion, i.e. Paramatma as Vasudeva, his Vyuha as Samkarshana, Yogamaya as Subhadra, and his Vibhava as Sudarsana. Vishwakarma appeared in the form of an artisan and prepared images of Jagannath, Balabhadra and Subhadra from the tree

When this log, radiant with light was seen floating in the sea, Narada told the king to make three idols out of it and place them in a pavilion. Indradyumna got Visvakarma, the architect of Gods, to build a magnificent temple to house the idols, and Vishnu himself appeared in the guise of a carpenter to make the idols on condition that he was to be left undisturbed until he finished the work.

But just after two weeks, the Queen became very anxious. She took the carpenter to be dead as no sound came from the temple. Therefore, she requested the king to open the door. Thus, they went to see Vishnu at work at which the latter abandoned his work leaving the idols unfinished. The idol was devoid of any hands. But a divine voice told Indradyumana to install them in the temple. It has also been widely believed that in spite of the idol being without hands, it can watch over the world .

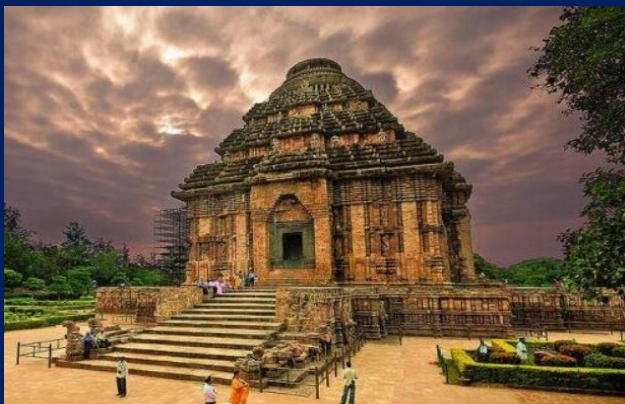

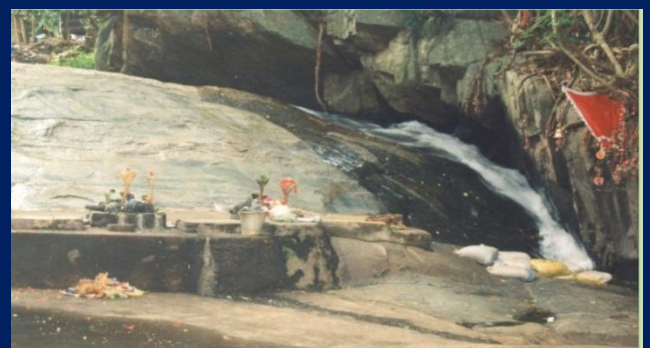
